Foreword

2011 was an active year for Baltic Region Healthy Cities Association. At the beginning of the year, BRHCA entered a new re-designation period (28.2.2011-28.2.2015) as WHO Collaborating Centre for Healthy Cities and Urban Health in the Baltic Region. The strategy of the Association was updated in spring 2011 with the help of a knowledgeable team of the representatives of the member organizations and the board of the Association. Finally, new statutes came into force.

During the year the Association continued networking activities with several partners, e.g. European Healthy Cities Network and Northern Dimension Partnership in Public Health and Social Well-being (NDPHS). Besides strengthening the cooperation with long-lasting partners, the Association managed to create new bounds with e.g. Union of the Baltic Cities - Commission for Social Affairs and Health, European Public Health Alliance and ScanBalt.

At the local level, Association supported the programme of Turku European Capital of Culture 2011. We organised a seminar on Culture and Wellbeing during the Baltic Sea Forum of Centrum Balticum as well as were involved in the organizing committee of Cultwell - International Congress on Culture, Health and Well-being.

Speaking of communication activities, year 2011 was very active as we managed to gain attention not only of local, but also of international media. With three articles in Turun Sanomat, a report about urban health efforts in Turku aired in BBC Radio 4, presentations at Nordic Public Health Conference and World Conference of TAFISA - The Association for International Sport for All, and several posts published in Innokylä blog, the Association received a lot of visibility.

I would like to express my special thanks to an enthusiastic office team. For Agnieszka Ilola and Karolina Mackiewicz no task is too challenging, no matter if it is participation in a panel discussion at an international congress or an organization of the visit of the Polish Ambassador in the Baltic Sea House.

Sincere thanks to Riitta Asanti who resigned from the position of Chairman of the Board after having supported the Association for years. Warm thanks to Heini Parkkunen who supported the Association with her enthusiasm and energy even after returning to her position of Senior Special Advisor in the City of Turku.

The board had an active role in the Association's issues. Thanks also to Turku Urban Research Programme with which we plan new activities for 2012, for good cooperation so far.

Challenges in public health continue to exist, and they are even more evident in hard economic times we live in. There is a strong need for cross-sectoral effort, as it is for Healthy Cities work. Therefore, by closing the 2011 we enter 2012 with new ambitions.

1 OPERATIONAL ENVIRONMENT

WHO TERMS OF REFERENCE

WHO and the Association have agreed on the cooperation for the Collaborating Centre:

- Assist cities in the Baltic Sea Region in implementing WHO Healthy Cities' goals and motivate new cities into joining the Network;
- Build capacity for health and well-being by bringing appropriate expertise to the local level with relevant institutions and organisations;
- Enhance the visibility of the Healthy Cities operations in the Baltic Sea Region;
- Build an information system of best practises and the state of well-being in cities belonging to the Healthy Cities networks;
- Network with local, national and international health and well-being experts (including other WHO collaboration centres);
- Establish research and development cooperation with the Urban Research Unit of the City of Turku and member organisations of the Association.

ORGANISATION OF THE ASSOCIATION

Baltic Region Healthy Cities Association is located in Turku, Finland and has four members: City of Turku, University of Turku, Åbo Akademi University and Social Insurance Institution of Finland. The new statutes were approved by the National Board of Patents and Registration of Finland in August 2011 and they ensure a vivid administration for the work.

Activities of the Association are supervised by the Board which gathered in seven ordinary and in four strategy meetings in 2011. The statutory meetings of the Association were held in April, June and December. A preparatory group consisting of the Chairpersons, City of Turku representative and Executive Director met six times during the year. An agreement with City of Turku was signed in October where cooperation principles were agreed on.

HEALTHY CITIES NETWORKS IN THE BALTIC SEA REGION

The goal of the Association is to improve health conditions of cities in the Baltic Sea Region and to support the World Health Organization (WHO) programmes which serve these purposes. The Association assists the network cities in the implementation of the Healthy Cities themes.

The overarching goal of the Phase V Healthy Cities activities is: Health and Health Equity in All Local Policies and core themes are: 1/ creating caring and supportive environment, 2/ healthy living, 3/ healthy urban environment and design.

At the end of 2011 there were 24 cities or regions officially designated or applied in the Healthy Cities network in 10 countries around the Baltic Sea (Figure 1.). There are around 200 cities or regions as direct members to WHO in the Healthy Cities network. When we take into account the national networks there are over 1400 cities or regions from more than 30 countries in WHO European Healthy Cities. www.euro.who.int/healthy-cities.. The membership of St. Petersburg is in the process.

STRATEGY OF THE ASSOCIATION

The two main activities of the Association are: 1) networking, training, coordination and 2) health promotion project work.

Vision

The Association is a recognized actor in cross-sectoral health promotion work by WHO, cities and partners in the Baltic Region.

Mission

The operations effect health promotion knowledge of the decision makers and wellbeing is involved in all local policies.

2 REPORT ON PROJECTS IN 2011

WHO Healthy Cities programme engages local governments in health promotion development through a process of political commitment, partnership-based planning and innovative projects. The goal of capacity building of the cities is to develop organisational change and human resource competence in order to put health high at the political agenda.

Healthy Cities requires systematic and multidisciplinary cooperation between different administrations at the local, national and international level. Networking with various health and well-being experts and institutions is needed to share the learning and show the evidence-based results of Healthy Cities actions. The Association, together with the cities and various partners, aims at strengthening the role of health promotion and Healthy Cities in the Baltic Region.

In 2011 Association participated in the meetings of Finnish, Russian, Danish and Nordic National Healthy Cities networks promoting good practices and information exchange. New cooperation possibilities were developed and resulted in new joint initiatives with many Baltic Sea Region stakeholders: Northern Dimension Partnership in Public Health and Social Well-being (NDPHS), National Institute for Health and Welfare in Finland (THL), UBC Commission on Environment and Sustainable Development and Health and Social Affairs as well as TAFISA, ScanBalt and Innokylä.

Action 1 Support for Healthy Cities activities

In 2011, the Association participated in meetings of the network cities and national networks in Baltic Sea Region to support and strengthen their commitment to health and Healthy Cities. BRHCA was present during the Danish 20th Healthy Cities Annual Conference which took place in March in Fredericia. In November, Association gave a presentation at the Russian Healthy Cities Association Annual Conference. In Finland the Association participated in the National Network meetings in June and November as well as in Terve Kunta board meetings. Association, City of Turku, Kunto ry and TAFISA – The Association for International Sport for All organised training for cities in 3AC (Active Cities, Active Communities, Active Citizens) in October in Jurmala, Latvia.

Being strongly involved in the work of Finnish National Network, BRHCA participated in a meeting of coordinators from national networks of Healthy Cities hold in Oeiras, Portugal. There, BRHCA gave presentations about the activities carried out in Baltic Sea Region and in Finland. It was learned that different national network use various means of promotion, ranging from production of publications to training of politicians, in order to raise the profile of public health work.

In June the Association participated in the Annual Business and Technical Conference of the WHO European Healthy Cities Network and of the National Healthy Cities Networks in Phase V in Liege, Belgium. During the conference, representatives of the Association were working as chairman and reporters in some of the sessions. Promotion materials of Turku projects and congresses were distributed.

At the Nordic Public Health Conference in August in Turku Association, together with Nordic national Healthy Cities network, organised a session 'Ownership of Public Health – How?". BRHCA invited Finnish speakers Maija Perho and Anne Santalahti from City of Turku. Moreover, during a conference the Association presented a poster on Healthy Cities, organised a cultural city walk for the participants, and hold an evening gathering in Ruissalo for the coordinators Nordic Healthy Cities networks.

During the Cultwell conference, in September in Turku, the Association organized a meeting with Healthy Cities coordinators from Baltic Sea Region. Moreover, training on health equity – a focus theme of Phase V, was planned but had to be cancelled due to the low participation.

In December, the representative of St Petersburg Health Committee visited Turku in order to learn about the practicalities in organising a Healthy Cities Annual Conference and the procedure of applying for the network membership. BRHCA supports St Petersburg in their efforts to become Healthy City.

In February the Association took part in planning meeting in Helsingborg, Sweden of the European Healthy Cities Research Centre (HAVEN) coordinated by the City of Helsingborg. Seven members, all part of the WHO Healthy Cities Programme (the cities of Helsingborg and Belfast, Universities of Geneva, Lund, West of England and Sheffield Hallam and Association) founded HAVEN in 2010. During the meeting an idea to set up a joint project was discussed. However, due to the lack of resources, the realisation of this plan was suspended.

The Association is involved in organization of WHO 8^{th} Global Conference on Health Promotion, which will be held in Helsinki in 2013. In November the Association met Agis Tsouros from WHO Europe – Centre for Urban Health, to discuss the role of BRHCA, future cooperation and funding opportunities.

In December the Association visited the Finnish Ministry of Social Affairs and Health to report on the activities carried out in 2011 and to present the Annual Plan for 2012.

Action 2 Baltic Profile

During 2011, the suitability of the use of Baltic Profile for research purposes with Åbo Akademi University was discussed. However, as the data published in the Profile vary a lot, and the copyrights are strict, the use for other purposes as information is limited and may remain a continuous challenge.

Action 3 Baltic Sea House Collaboration

The Baltic Sea House in Turku hosts four organisations: Baltic Region Healthy Cities Association, Centrum Balticum, UBC Environment and Sustainable Development Secretariat and Valonia - Service Centre for Sustainable Development and Energy Issues of Southwest Finland.

In 2012 BRHCA participated in an art bicycle event organised by Valonia in April, where the health benefits of biking were presented along with those environmental and cultural. At the Baltic Sea Forum, organized by Centrum Balticum in May in Turku Association hosted a seminar on wellbeing and health. It was arranged together with Turku 2011 Foundation. Later, in October, Executive Director was a guest of XI General Conference of Union of the Baltic Cities, in Liepaja, Latvia, where she gave a presentation about healthy ageing.

Moreover, the Association supported UBC in organizing the conference "Solutions, local, together – Nordic Conference on Sustainable Development in the Baltic Sea Region" (January) by taking care of some of the practical arrangements and organizing a walk which combined culture and physical exercise. BRHCA also participated in Baltic Sea Action Group seminar organized in the honour of Swedish Royal Princess Victoria during Her visit to Turku in September.

To sum up, 2011 was fruitful for the cooperation in a Baltic Sea House. The common efforts were prised by annual pre-Christmas Glögi event, hold in November, which collected over 110 guests. The guest of honour was Polish Ambassador to Finland, Mr Janusz Niesyto, who gave a speech about Polish Presidency in the Council of European Union. Executive Director of the Association opened the event.

Action 4 Communication

In 2011 the Association increased the visibility of its actions by writing three articles in the local newspaper Turun Sanomat (Sanna Salanterä & Johanna Reiman, Jukka Saukkolin & Johanna Reiman, Mikko Vienonen & Johanna Reiman), articles in Aivoliitto (Finnish Brain Association) magazine and Union of Baltic Cities UBC Bulletin as well as four posts in Innokylä blog (www.innokyla.blogspot.com). The objective of Innokylä is to develop new ideas in social and welfare.

The website of the Association (<u>www.marebalticum.org</u>) was updated regularly throughout the year. Newsletter was produced in an electronic form and sent by email to over 500 recipients from Turku, Baltic Sea Region, Europe and European Healthy Cities Network four times.

Two press releases were published: 1/ about a report on public health and urban planning in Turku, produced and aired at BBC Radio 4 Turku and 2/ election of Maija Perho to the Advisory Board of European Healthy Cities. Association hosted Charlotte Ashton, the reporter of BBC Radio 4 and involved urban planning experts from City of Turku to show interesting local examples, e.g. investments in Kakola and Linnanfältti. Charlotte Ashton also interviewed e.g. Research Director of Urban Research Programme and Research & Development Manager of Turku 2011 Foundation.

Additionally, Healthy Cities themes and examples of good practises were published in the Books of Abstracts of Healthy Cities Conferences in Liege, Nordic Public Health Conference in Turku and TAFISA World Conference in Antalya. Promotional brochure of campaign Pyörallä töihin – Biking to Work was produced by the Association together with Valonia.

Evening seminar was hosted by Association in April to celebrate World Health Day. The event was organized together with University of Turku, National Public Health Institute and Turku Science Park Oy and took place in Turku City Library. Antibiotic resistance of bacteria was the WHO theme in 2011 and University of Turku and National Public Health Institute have considerable expertise in this field. In November, in order to highlight another occasion – the World Heart Day - an afternoon event was organised with City of Turku / Monitori service point, South-western Heart Association and Tmi Tuula Vainikainen in shopping centre Skanssi. The programme, which was coordinated by the Association, included lectures on physical activity, nutrition and how to take care of your heart.

Presentations about involvement of local decision makers in health promotion were given for ScanBalt Executive Committee meeting in Helsinki in March and in the 10th ScanBalt Forum in Heringsdorf in Germany in September.

Promotional materials of the Association were distributed during various events. The Baltic Office personnel was active in communication with the Healthy City coordinators on the regular basis via e-mails and telephone. Association promoted Turku as the European Capital of Culture 2011 and participated in the development of the international strategy for City of Turku. Communication units of University of Turku and Åbo Akademi University were visited in order to get to know each other's activities. Discussions about cooperation were also held with Baltic Sea Region University Network. Association learned about health advocacy and coalition building during the training organized in Brussels by the European Public Health Alliance. Networking training was received during the Net-map summer school.

Action 5 Dissemination of Physical Activity/Active Living practises

In 2011 Association continued as a member of the Health Enhancing Physical Activity network (WHO/HEPA Europe) and in October took part in the 3rd conference "Bridging the gap between science and practice" and the 7th meeting of HEPA Europe in Amsterdam, Netherlands. During those events, representative of the Association, Riitta Asanti, was chosen to the sub-network on children and youth. HEPA Europe is an important channel to disseminate good practices from City of Turku.

During the World Congress of TAFISA – The Association for International Sport for All in October in Antalya, Turkey, the Association gave a presentation about sports activities organized by City of Turku for immigrants. The 3AC (Active Cities, Active Communities, Active Citizens) seminar was organized by the Association together with TAFISA and Kunto ry in Jurmala, Latvia in October collected several cities from Baltic Sea Region to discuss means of promotion of physical activity in the cities. Finally, art bicycle event organized with Valonia promoted physical activity (cycling and walking) when going to work.

Actions 6 & 7 Project implementation and planning of projects, seminars and events

In 2011 the Association was involved in 11 project applications and in organizing Cultwell conference:

- Healthier People: Management of Change through Monitoring and Action EU Delegation to Russia, 31.5.2011 (Partner), project received funding;

- ESIKUVA Esteettömät kulttuuri- ja virkistyspalvelut kunnissa THL, 15.6.2011 (Lead Partner), did not receive funding;
- Potkua ruoasta ja liikunnasta, kestävät ruokavalinnat Turun kaupungin henkilöstön ja oppilaiden keskuudessa – THL, 15.6.2011 (Lead Partner), did not receive funding;
- Tools for Cooperation between Immigrants, Police and Social work (TIPS) European Integration Fund, 31.10.2011 (Partner), waiting for decision;
- Alcohol and Drug Prevention among Youth in Baltic Sea Region Central Baltic Programme, 15.8.2011 (Partner), waiting for decision;
- Promoting policies and improving delivery of services to the HIV+ mothers along with support for families with persons living with HIV – EU Delegation to Russia, 6.10.2011 (Lead Partner), waiting for decision;
- Tiedotustoimittaja, Varsinais-Suomen sairaanhoitopiiri, did not receive funding;
- Hyvinvointiklusterin koordinointi, Varsinais-Suomen liitto, coordination was accepted in the cluster board but the project did not receive funding.

Of the project applications made before 2011 the following projects were being carried out:

- HEPROGRESS Reducing health related social and gender inequalities and barriers to social and economic participation;
- VIRTU Virtual Elderly Care Services on the Baltic Islands.

Of the project applications made in 2010 the following projects did not receive funding in 2011:

- UP! Developing urban planning for physical activity and social inclusion in Udmurt Republic;
- Curbing HIV epidemics and health inequalities in Eastern Europe by improving the capacities of NGOs in Armenia, Belarus and Russia;
- Utilising the city setting to promote social inclusion through sport;
- ACCURE Improving the accessibility of cultural and recreational services;
- FEMIS-Fight against HIV/AIDS feminisation in St. Petersburg, Leningrad Region and East-Estonia;
- DECiPHEr Developing an Evidence-Based Approach to City Level Public Health Planning & Investment in Europe.

The following projects are waiting for approval:

- BADY Alcohol and drug prevention among youth in Baltic Sea Region (Flagship project of the EU Strategy for Baltic Sea Region);
- Tools for Cooperation between Immigrants, Police and Social work (TIPS) European Integration Fund, 31.10.2011 (Partner);
- Alcohol and Drug Prevention among Youth in Baltic Sea Region Central Baltic Programme, 15.8.2011 (Partner);
- Promoting policies and improving delivery of services to the HIV+ mothers along with support for families with persons living with HIV EU Delegation to Russia, 6.10.2011 (Lead Partner).

FORUM project received funding from the Nordic Council of Ministers but the project had to be cancelled due to lack of commitment of the partners. The project aimed at creating a FORUM for local decision makers and public health professionals for meeting, discussion and developing policies together. The project would have brought together Nordic Healthy Cities national networks from Denmark, Finland, Norway and Sweden.

HEPROGRESS project develops local interventions to reduce social and gender inequalities in health and social participation at a local community level in Latvia and Norway. The actions focus on local and regional capacity building among practitioners, politicians and academic institutions. Project has three target groups: citizens from high risk groups, local and regional politicians and staff of academic institutions. Project is funded by EU Commission DG Employment, Social Affairs and Equal opportunities and runs until the end of November 2012. The partners are Østfold County Council, Østfold University College, Volda University College, Amata Municipality, University of Latvia, Municipality of Moss and Baltic Region Healthy Cities Association. The Association is part of Project team and steering group. It is responsible for the dissemination of knowledge of the project to the Healthy Cities and other stakeholders in the Baltic Region. In 2011 there was an opening conference in Amata, Latvia and three project meetings.

Association supported organising International Congress "Culture, Health and Well-being" (CultWell 2011) which was part of the project "Turku - A Prosperous City of Science, Humanities and Culture" (TIUKU). The Association was a member of the organising committee and promoted the congress among the European Healthy Cities, WHO experts and other partners. The Association engaged one of the keynote speakers, Professor Hugh Barton from University of West of England. Additionally, special programme about healthy urban planning was organised for him in the cooperation with City of Turku. Association continued cooperation with the NDPHS Expert Group on Non-Communicable Diseases on the development of two joint projects. Several project meetings were held, but project applications were not yet finalised.

3 FINANCES

According to the financial statement, the Association received for its operations: EUR 80 000 from the City of Turku, EUR 50 000 from the Ministry of Social Affairs and Health, EUR 2 700 from membership fees and EUR 18 160 as project income, which makes altogether EUR 150 860. Total proceeds in 2011 were EUR -175. The external project funding was lower than budgeted, mainly due to the cancellation of FORUM project. Unfortunately, receiving additional funding for actions in health promotion from the local, domestic or international sources remain challenging, even though the Association is effective in project development and cooperates with experienced partners.
